23 On November 6, 2024, at 10:00 a.m., a status conference was held in the above-captioned
24 chapter 11 bankruptcy case of MASHindustires, Inc. (the “Debtor”), the Honorable Theodor Albert,
25 Chief United States Bankruptcy Judge, presiding. Susan K. Seflin appeared on behalf of the Debtor.
26 Other appearances were as noted on the record.

27 Based upon statements made during the status conference, and for good cause appearing
28 therefor,

1 IT IS HEREBY ORDERED THAT

2 1. The deadline for the Debtor to file and serve an amended chapter 11 plan of
3 reorganization is November 14, 2024.

4 2. A hearing on the confirmation of the Debtor's amended chapter 11 plan of
5 reorganization shall be held on January 8, 2025, at 10:00 a.m. (the "Plan Confirmation Hearing").

6 3. The deadline for the Debtor to file and serve notice of the Plan Confirmation Hearing is
7 November 14, 2024 (the "Notice"). The Notice shall contain the following:

8 a. The deadline for ballots to be completed and returned by no later than
9 December 6, 2024.

10 b. Any objections to the confirmation of the Debtor's amended chapter 11 plan
11 of reorganization shall be filed and served no later than December 13, 2024.

12 4. The Debtor shall file and serve the Debtor's confirmation brief and evidence, including
13 declarations and the ballot summary, in support of confirmation, and in reply to any objections to
14 confirmation, by December 20, 2024. The brief and any supporting evidence must be served on the
15 United States Trustee, subchapter V trustee, and any party who objects to confirmation.

16 IT IS SO ORDERED.
